# RIO GRANDE HABITAT RESTORATION AND SEDIMENT CONCERNS ON AGENDA FOR FEBRUARY 23 PUBLIC MEETING

The United States Section of the <u>International Boundary and Water Commission</u> (USIBWC) has scheduled a public meeting of the <u>Rio Grande Citizens Forum</u> (RGCF) on **Thursday, February 23, 6:30 – 8:30 p.m. MST via webinar** to discuss habitat restoration efforts underway along the Rio Grande, regional sediment concerns, and the effectiveness of *No Trespassing* signage along the levees. The purpose of the Rio Grande Citizens Forum is to promote the exchange of information between the USIBWC and the community about Commission activities and related projects in the greater El Paso, TX – Las Cruces, NM region.

Elizabeth Verdecchia, USIBWC Natural Resource Specialist, will give an update on USIBWC's activities to implement riparian and aquatic habitat restoration projects along the Rio Grande in southern New Mexico and west Texas over the last several years. USIBWC has implemented over 508 acres of riparian restoration on 22 sites and is planning for several aquatic habitat sites. Removal of invasive species along the areas of the floodplain will also be discussed.

Xochitl Aranda, USIBWC Chief of the Operations and Maintenance Division, will present on the effectiveness of *No Trespassing* signage on levees. In January 2021, signs were installed at levee access ramps and habitat restoration sites along the Rio Grande to notify the public of designated use areas, such as for walking and cycling. Motorized vehicles, open fires, and camping are never allowed. With the support of the Doña Ana County Sheriff's Office, the USIBWC has seen a reduction in prohibited activities.

Ms. Aranda will also discuss the agency's response to flooding concerns in Hudspeth County, Texas. For many years, landowners along the Rio Grande in Hudspeth County experienced year-round flooding on their lands adjacent to the river. This is due to the sediment carried by the river and building up at Little Box Canyon, creating a plug in the river, causing the flow to back up. In 2020, the USIBWC hired a contractor to remove the sediment plug and, since then, USIBWC personnel have maintained the river's flow by preventing sediment from flowing downstream into Little Box Canyon so adjacent properties don't experience flooding.

In other business, John Sproul, Program Coordinator and Manager of Rio Bosque Wetlands Park for the University of Texas at El Paso Center for Environmental Resource Management, will present on how the Rio Bosque Wetlands Park is integrated into water management in the Rio Grande valley. The Rio Bosque Wetlands Park is a 372-acre area next to the Rio Grande that is the site of a long-term ecological restoration project. Wetland and

riparian habitats are the centerpiece of this restoration effort, and both depend on reliable availability of water. The park receives water from three sources: groundwater, Rio Grande Project irrigation water, and treated water from the Roberto Bustamante Wastewater Treatment Plant, which is the main source. The presentation will cover delivery of water to the park, its distribution within the park, and where it goes when it leaves the park.

USIBWC Commissioner Maria-Elena Giner will also attend to share information with the Citizens Forum about Commission initiatives.
